Man Investments AG ("MIAG") information document regarding services, activities, products and operations offered to its clients (the "MIAG Information Document")

a) Name and address of MIAG (art. 8 para. 1 letter a FinSA)

Man Investments AG ("**MIAG**"), located at Huobstrasse 3, 8808 Pfäffikon SZ, Switzerland, is a wholly owned subsidiary of Man Group plc.

b) Field of Activity and supervisory status (art. 8 para. 1 letter b FinSA)

MIAG provides the following activities:

- advisory and discretionary investment management and/or sub-investment management services in relation to collective investment schemes;
- advisory services to pooled investment vehicles such as securitisation vehicles (known as collateralised loan obligations);
- distribution and marketing services for professional and institutional clients in Switzerland under the Financial Services Act or for other affiliated investment managers; and
- acquisition and disposal of financial instruments pursuant to art. 3 letter c cipher 1 FinSA via its webpage www.man.com.

It is authorised and supervised by the Swiss Financial Market Supervisory Authority FINMA, Laupenstrasse 27, CH-3003 Bern, Switzerland (www.finma.ch) as asset manager of collective investments as well as representative of foreign collective investment schemes.

c) Possibility of initiating mediation proceedings before a recognised ombudsman (art. 8 para. 1 letter c FinSA)

MIAG has affiliated itself with Verein Ombudsstelle Finanzdienstleister (OFD) at Bleicherweg 10, CH-8002 Zürich, which is a recognised ombudsman office of the Federal Department of Finance in accordance with Art. 84 para. 1 FinSA. Mediation proceedings before a recognized ombudsman may be initiated in accordance with Title 5 FinSA.

d) The general risks associated with financial instruments (art. 8 para. 1 letter d FinSA)

Financial instruments are always associated with risks. These can turn out to be to your advantage or to your disadvantage. When offering financial instruments to you, MIAG does not render any additional financial service. It does neither take any investment decision for you nor recommend any financial instrument to you. All investment decisions are taken by yourself, and you will be responsible for the consequences.

The costs involved with the offered financial instruments are disclosed in the legal documentation (prospectus, offering document etc.) of the financial instruments offered by MIAG. MIAG does not charge you any additional costs for the offering of financial instruments.

f) The business affiliations with third parties in connection with the financial service offered (art. 8 para. 2 letter b FinSA)

MIAG is part of the Man group of companies ("Man Group"). The ultimate holding company is Man Group plc. You may find more information on Man Group on the website www.man.com.

g) The market offer taken into account when selecting the financial instruments (art. 8 para. 2 letter c FinSA)

MIAG only offers financial instruments offered by Man Group. MIAG does, thus, not offer any financial instruments sponsored or managed by other asset managers. The market offer taken into account by MIAG is, thus, limited to financial instruments of Man Group. MIAG's core client base and focus is on institutional/professional investors as well as on financial institutions and asset managers who may service private clients but also invest their own funds.
